# **Summary of Process**



# **Manuscript Publication**



Lead author submits a plain language summary and draft of manuscript to PDAC via form on CCNA website

 At least four weeks prior to intended date of submission to journal

PDAC reviews manuscript/approves submission to journal

- Within three weeks of submission to CCNA Central
- CCNA Central informs author of PDAC decision

When manuscript is accepted by journal, lead author sends final version PDF to CCNA Central

 CCNA Central updates publications lists and places the plain language summary, abstract, and publication details on the CCNA website.

Publication will be Open Access within 12 months of publication  As per CIHR policy: <u>https://cihr-irsc.gc.ca/e/32005.html</u>

# Manuscript submissions

All CCNA related and acknowledged manuscripts must be reviewed by the PDAC *prior* to submission

#### What PDAC checks for:

- Women, Sex, Gender and Dementia (WSGD) considerations (section 3.4 of the policy)
- Inclusion of a plain language summary (section 3.5)
- Proper acknowledgement of CCNA (section 9)
- Citation of relevant papers as required (section 9)
- Inclusion of a statement of ethical approval (section 9.3)
- Compliance with other PDA requirements
  - E.g. overlap with other declared CCNA studies, fair representation of CCNA and of the contribution of investigators, etc.

Note: Turnaround time is approximately three-weeks so keep that timeline in mind when planning

# **Acknowledgements**



CCNA is not a funding organization, and statements such as "This project was funded by CCNA..." should be avoided

Funding of CCNA by CIHR and other funding partners must be acknowledged.

Exact wording may vary depending on the journals and the type of publication, but a default statement is:

Name X is a member of Team (or Platform or Cross-cutting Program) which is a part of the Canadian Consortium on Neurodegeneration in Aging (CCNA). The Canadian Consortium on Neurodegeneration in Aging is supported by a grant from the Canadian Institutes of Health Research with funding from several partners.

### **Submission Checklist**



- Complete PDAC form on <u>CCNA's website</u>
- 2. A 300 word (max) plain language summary (imagine the readers are people with lived experience of dementia)
- 3. Your manuscript (in Word format)

#### **COMPASS-ND Data Access**
